Safety is a top priority for all students, and we hear the concern that walking to and from school for extracurricular activities could present a challenge for some Staley students. At the same time, it's important to acknowledge that this transportation challenge affects a broader group of students in the district who also live on the opposite side of the Tollway or State Highway 121 from their zoned campus. District leadership is actively reveiewing options and will work with campus counselors and coaches to help ensure that participation in extracurricular activities is not limited by transportation needs.

opportunity within Frisco ISD. Additionally, if Staley closes at the end of the 2024-25 school year, staff who move to a like position within FISD will not receive less in annual compensation for 2025-26 than they received in 2024-25.

"Good standing" means the staff member has received satisfactory performance evaluations from their immediate supervisor.
