SCHOOL BUS SAFETY RULES AND REGULATIONS FOR SPECIAL
NEEDS BUS RIDERS

- 1. Students must always remain seated and face the front of the bus. Aisles must always remain clear. Students should keep their hands to themselves.
2. Any or all seats will be assigned at the driver's/monitor's discretion.
3. Nothing may be extended outside the windows at any time.
4. Emergency doors and windows may not be used to enter or exit except for emergency purposes.
5. No type of weapon, explosive, firework, sharp, or pointed objects will be permitted.
6. No type of alcoholic beverage, controlled drug, tobacco, or substance will be permitted.
7. Students must always follow the driver's or monitor's instructions.
8. Cursing, obscenities, harassment, and scuffling are forbidden.
9. Students may only utilize their designated bus stop as assigned by Special Needs Routing.
10. No objects may be thrown, tossed, or pitched inside or outside of the bus.
11. All items brought on board must fit in the student's lap. Seats will not be taken by large band instruments, schoolwork, projects, or any item which takes up another student's seat. Please make special arrangements for transporting these large articles. Skates and skateboards are not permitted. Only two oxygen tanks will be transported at one time. We do not transport suitcases or other personal items not required by the school.
12. Drivers will wait two minutes for students at the bus stop. We will not sound the horn or ring the doorbell for students to come out of their residence.
13. Frisco ISD students and Frisco ISD staff are the only authorized persons to board school buses. Parents, parent sponsors, or guests must receive an authorization form from a Frisco ISD Administrator to board the bus.
14. Only service animals are allowed on the bus. No other animal, pet, or bird is permitted.
15. Students may not eat or drink on the bus.
16. Please call 469-633-6155, if your child is not riding the bus for any route, AM or PM.
17. A stop where the student is a no call, no show for the route three consecutive days will be removed from the route until the Transportation Department receives a request to reinstate. This may take up to 10 school days to process from the time the new request is received.

Special Needs Transportation Parent Help Sheet

Dispatch: 469-633-6155

- Please notify dispatch if your student will not ride AM, Mid-Day, or PM
- Please have the teacher notify transportation if your student will be out more than three days.
- Requests for transportation changes must be communicated only from the teacher to the transportation department.
- Transportation is only provided to and from the addresses on the students IEP.
- Any changes to your child's schedule must be sent to the campus to make the change. All changes must be made on the IEP and received by transportation before we can make any changes to your students schedule
- It can take up to 10 school days to process changes. (Time is needed to notify other students / parents affected)
- Please do not contact dispatch to change services for your child; it must go through the campus. This also pertains to changes for days of the week. Transportation is only provided for the days requested.
- Please have your student ready before the scheduled pick-up time.
- The driver will only wait two minutes after your child's scheduled pick-up time before departing if an occasional delay occurs.
- Transportation becomes the responsibility of the parent /guardian if a student misses the bus.
- Any student delivered late due to a delayed FISD bus will receive an excused tardy.
- Parents must be available to receive their child as early as the school dismissal time, regardless of the scheduled drop off time.
- Drivers are instructed to return students to their campus, if there is not an approved adult to receive the student, unless the student has a release to be left unattended form on file. The driver/monitor MUST see the parent/guardian accepting the child at the time of drop off.

- Favor notifique al despacho si su estudiante NO viajará en el camión escolar en la AM, Media-Tarde o PM.
- Favor de pedirle a su maestra que notifique al departamento de Transportación cuando su estudiante no estará en la escuela por más de 3 tres días.
- Solicitud de cambios de transporte **debe** ser comunicada solo por el maestro al departamento de transporte.
- Cualquier cambio en el horario de su hijo debe enviarse al campamento escolar para hacer el cambio. *Por favor, no se comuniquen con la despachadora para cambiar los servicios para su hijo; Debe pasar por el campamento. Esto también se refiere a los cambios para los días de la semana. El transporte solo se proporciona para los días solicitados.
- Favor de tener listo al estudiante antes de su hora prevista para ser recogido.
- La responsabilidad de Transportación es del padre/guardián si el estudiante pierde el camión escolar.
- Cualquier estudiante que llegue tarde por causa de una tardanza del camión escolar de FISD recibirá una tardanza con excusa.
- Exigimos que los padres estén disponibles para recibir a su estudiante tan temprano como a la hora de salida de su escuela.
- Los Conductores tienen instrucciones de devolver al estudiante a su escuela si no hay adulto autorizado para recibir al estudiante.
